Internal AWARDS

Prof Hanri Mostert won the UCT Meritorious Book Award for *Mineral Law: principles and policy in perspective*.

External AWARDS

Prof Hugh Corder directed a project on the appointment of judges in six Commonwealth countries, funded by the Claude Leon Foundation. Outputs include a book and guidelines for judicial apointments.

The DST/NRF SARChI Chair: Mineral Law in Africa was awarded to **Prof Hanri Mostert**.

The DST/NRF SARChI Chair in Customary Law, Indigenous Values and Human Rights, held by **Prof Chuma Himonga**, was renewed. Prof Himonga also published *Reform of Customary Marriage, Divorce and Succession in South Africa: living customary law and social realities*.

The Democratic Governance Research Unit received support from the Norwegian embassy for a project on Women Pioneers in Law.

The Centre for Law and Society (CLS) received a substantial grant from the Constitutionalism Fund to support research and dialogue on critical issues in South African law and society.

The IP Unit secured a follow-up grant of R14 million for the next three-year phase of their Open AIR project.

HIGHLIGHTS from June 2015 to June 2016

Prof Dee Smythe was appointed director of research.

The new phase of the Open African Innovation Research (Open AIR) project commenced in 2015. It seeks to solve a problem at the heart of innovation policy and practice: how to reconcile tensions between knowledge appropriation and access, between excluding and sharing, and between competing and collaboration. In doing so, the project helps in addressing some of the most significant innovation challenges: to promote population health, environmental sustainability, universal education, cultural participation, food security, poverty alleviation and economic growth.

The Centre of Criminology has been involved in the police-led process of implementing the Khayelitsha Commission of Inquiry recommendations.

The Tax Institute for Fiscal Research was established, a result of collaboration between the faculties of law and commerce, in cooperation with the International Bureau of Fiscal Documentation. The institute's aim is to be Africa's leading academic research institute in fiscal matters.

The Rural Women's Action Research Unit, formerly part of the Centre for Law and Society, and now reconstituted as the Land and Accountability Research Centre (LARC), has received a range of grants to support work on rural democracy and governance, including from the Raith Foundation, Claude Leon and Ford, and the Tshemba Foundation. Renewed grants were welcomed from the Millenium Trust, HBS and the Open Society Foundation, in respect of supporting strategic litigation.

Dr Hannah Woolaver was awarded a research grant of \$250,000 AUD from the Australian Research Council for a three-year research project in collaboration with Assoc Prof Sarah Williams of the Faculty of Law, University of New South Wales. The project, 'Evaluating Civil Society Participation before International Criminal Tribunals', provides the first comprehensive assessment of the methods by which civil society actors seek to intervene in international criminal tribunals and the influence of those interventions on legal outcomes, including the question of whether those interventions reflect the range of civil society interests in international criminal justice, or are limited to 'Western' perspectives.

DST/NRF SARChI Chair in Justice and Security **Prof Mark Shaw** published the book *A Citizen's Guide to Crime Trends* with **Anine Kriegler**.

Departmental Profile

The Department of Commercial Law is the biggest department in the Law Faculty in terms of both staff complement and student numbers. Several of its academic staff members hold doctoral degrees whilst a few others are currently working on their doctoral degrees. In addition, a number of academic staff members are working on new books or on new editions of established works. All of this enhances the department's scholarly achievements, as evidenced by the publications listed below. The Department now has three NRF rated researchers.

The Department has an increasing number of PhD and LLM by dissertation students and teaches most of the students who are taking the LLM by coursework and the Postgraduate Diplomas in Law. It graduated its first cohort of professional master's degree graduates at the end of 2014.

In the LLB programme the Department teaches compulsory courses in Corporation Law, Commercial Transactions Law and Labour Law. It offers 14 optional courses to final year students. The Department also offers specialised commercial law courses to nearly 2600 students from other faculties.

There are four research and teaching units which form part of the Department: the Institute of Development and Labour Law, the Centre for Comparative Law in Africa, the Shipping Law Unit and the Intellectual Property Unit.

The South African National Research Foundation (NRF) Chair of Security and Justice, a South African Research Chairs Initiative of the Department of Science and Technology and the NRF is hosted by the Law Faculty at the University of Cape Town. Professor Clifford Shearing, held the chair until August 2014. Prof. Mark Shaw took up this position with effect from 1 September 2014. Professor Elrena van der Spuy holds the Chair of Criminology in the Centre.

During the course of 2015 the work of the Centre was focused around some of the most pertinent challenges facing South Africa and Africa more generally within the overall context of an increasingly globalised world. This work included a strong emphasis on research in: (1) organised crime and illicit trafficking in South Africa and Africa, including with a focus on the evolution of criminal networks in fragile states and their impact on governance, democracy, livelihoods and the environment; (2) developments and challenges for policing, both public, private and community driven, and reforms; (3) urban safety challenges with a particular focus on the evolution of city insecurity in the 'global south'; (4) criminal justice policy questions, with an emphasis on developing country contexts; and (5) violent crime, with particular attention to its impact on youth and women.

Institute Profile

The Institute of Marine and Environmental Law undertakes research, teaching and consultancy in the fields of marine and environmental law both at the international level and in the context of Southern Africa. It also participates in multi-disciplinary projects in collaboration with other specialists in marine and environmental subjects. In 2015 members of the Institute worked collaboratively as well as individually on a number of projects. Professor Feris continued her work on environmental rights and on the legal implications of the concept of place. She presented a paper on environmental rights at a seminar on the legal foundation of environmental sustainability convened by the United Nations Environment Programme (UNEP) as part of the Midterm Review of the Montevideo Programme IV. In collaboration with Professor Glazewski, she continued work on water governance and in particular clarification of the concept "responsible authority" as it relates to Catchment Management Agencies. Prof Glazewski continued his research on transnational fisheries crime in collaboration with counterparts at NMMU and the Norwegian Ministry of Trade and Fisheries as well as research on legal and governance aspects of hydraulic fracturing in the Karoo. Professor Paterson continued with his research in the area of protected areas law and governance, biodiversity, land reform and community conservation. His research in these areas led to several publications on indigenous peoples' rights in the Central Kalahari Game Reserve, connectivity in the Greater Cederberg Biodiversity Corridor, and biodiversity and local governance. He also presented a paper at the IUCNAEL Colloquium held in Jakarta (Indonesia) focusing on participatory forest management. His main highlight of 2015, was completion of the IUCN Environmental Law Centre's Protected Areas Law and Governance Project, of which he was the lead author, and running workshops in Bonn (Germany) and Wuhan (China) focusing on the resources to emerge from this project. Micha Young continued to focus

on her key research area, being conservation in areas beyond national jurisdiction. During 2015, this resulted in a publication centred around the International Court of Justice's judgment in the whaling case. She also continued to further her research into a key principle underpinning governance in areas beyond jurisdiction - the principle of the freedom of the seas.

Unit Profile

The Democratic Governance and Rights Unit conducts applied and comparative research in the field of judicial governance with a particular interest in judicial appointments and gender equality and diversity in the judiciary and in the legal profession in both South Africa and the region. We provide bespoke research support to judges in the SADC region. We are a member of the international free access to law movement through our SAFLII and AfricanLII projects. We publish the largest free-access collection of legal materials from southern Africa and we are a leader in supporting and providing free access to Law on the continent.

In 2015, our researchers were engaged in a number of activities. Tabeth Masengu amongst others, spoke at the African international Association of Women Judges conference in Pretoria, organised a panel and spoke at the South African Development Community (SADC) lawyers AGM in Dar es Salaam, Tanzania and facilitated at a Judges training workshop held in Bagamoyo, Tanzania organised by Equality Now, an NGO based in Kenya. Tabeth concluded the national legal sector meetings, spoke at a Judges Matter meeting and provided strategic advice to the Malawi law society. She also published a chapter in Constitution Building in Africa (Visser and Steyler eds) and an article in the South African Journal on human rights. In the faculty, Tabeth taught three sessions of the Governing Under the constitution module to an LLM class.

Chris Oxtoby participated in a conference, convened by Professor Hugh Corder and the Bingham Centre for the Rule of Law, which developed a set of principles ("The Cape Town Principles") on judicial appointments in commonwealth countries. Chris supervised the preparation of three research reports and submissions for Judicial Service Commission interviews during 2015. He and Roger Gachago were involved in a joint project with Austlii to develop data mining facilities on the Saflii database. A paper reporting these findings is currently being finalised. The initial findings of this research were presented

by Gachago at the Law Via the Internet conference in Sydney in October 2015.

In September we hosted the annual International Law via the Internet Conference (LVI) in partnership with Kenya Law with participants from over 35 countries. Hosting the LVI in Africa provided a unique opportunity to combine advocacy for the now well-developed Free Access to Law Movement in Africa with practical models for implementing legal information technologies to further promote and increase the impact of open access to law and, consequently, greater access to justice. The conference tailored its plenary and parallel sessions to the challenges faced by the government, the judiciary, academic institutions, legal practitioners, and citizens in utilizing open access law in Africa in particular, and the developing world more generally.

We convened a forum for South African Judges in November which explored the theme of constitutional and transformative adjudication, and a forum for judges from other SADC regions in May, which focused on the separation of powers and case flow management. We continued our Court Intern programme in Malawi and Namibia. This is a partnership project with Oxford University's pro-Bono Public group through which we place postgraduate students as interns in superior courts. It continues to be well received by the courts. One UCT and one Oxford student were sent to the Supreme Court of Namibia, while two UCT students were sent to the Supreme Court of Malawi. Our 'virtual research assistant' project in the region continues to be popular with judges and lawyers in the region, and provides great opportunities for post graduate students to gain practical research experience whist providing high quality research support to judges around the region. Students at UCT worked on various projects for judges - from producing legal opinions and comparative research reports to the provision of articles and other background resources.

On a technical level, we started development of an offline legal resource "Pocket Law" which will be updatable when there is access to the internet - this will be rolled out in 2015 as a research tool for students, judges and practitioners in the region.

With a primary focus on producing excellent empirical studies of law in context, based on participatory methodologies and collaborative partnerships, CLS is committed to sound research underpinning evidence-based advocacy on critical legal and social issues. In recent years we have expanded our areas of focus, retaining the emphasis on participation, knowledge-sharing, and capacity-building as central tenets of our Centre's scholarly approach. In 2009 the Rural Women's Action Research Programme (RWAR) was established within the Centre, with the objective of challenging government policies and laws that undermine the citizenship rights of the 18 million people living within them and set the former homelands apart from the rest of South Africa as zones of chiefly sovereignty. We are committed to foregrounding the understandings, initiatives and expertise of people living in rural areas in informing law and policy. To this end we support rural leaders to make direct submissions to parliament and engage directly in policy debates. We engage in ongoing conversations with our rural partners in order to develop joint strategies for change. We have made a significant contribution to shifting academic discourse in the area of rural power relations and citizenship rights and in creating a space for community-based groups and organisations to challenge the government's approach to land reform, traditional courts and the elevation of chiefly interests at the expense of the citizenship rights of ordinary people. Our work has also contributed to extensive media coverage and political debate about these issues, and we have provided extensive research and conceptual support in relation to a number of cases in the Constitutional Court.

The Centre offers a postgraduate Programme in Criminology, Law and Society, in partnership with the Centre for Criminology, to train the next generation of scholars concerned with issues of law and society in Africa.

The Refugee Rights Unit is a multifunctional unit with four main components: It incorporates a Law Clinic which provides direct legal services to thousands of refugees and asylum seekers; it conducts Applied Research in refugee law and related topics; it teaches Refugee and Immigration Law to the undergraduate LLB students and Refugee Law and Human Rights to the Masters Students; and, it undertakes a significant amount of targeted advocacy and training of government officials, the judiciary, civil society partners and refugee communities.

The Refugee Rights Unit is an implementing partner of the United Nations High Commissioner for Refugees (UNHCR) and is funded UNHCR, The Sigrid Rausing Trust and Hivos.

The close relationship between the Refugee Law Clinic's practice the Unit's teaching of Refugee and Immigration Law courses to LLB and LLM students, and the Unit's research is a unique aspect of the Unit's work. The Refugee Law Clinic provides the Unit with a close link to the practical application of refugee law in South Africa and therefore directly informs and supports the Unit's teaching activities and research outputs. Students often engage with the most current issues facing refugees and asylum seekers in South Africa, including those involved in the strategic litigations undertaken by the Refugee Law Clinic. Students are also encouraged to volunteer at the Refugee Law Clinic in order to gain practical experience and fulfil community service requirements. The Unit's teaching component includes the direct supervision of undergraduate and graduate level research work in the field of refugee and immigration law.

The Working Paper Series, (http://www.refugeerights.uct.ac.za/research/working_papers/) publishes the research reports of the Refugee Rights Unit, occasional papers of the Unit members and versions of some of the papers presented by the Refugee Rights Unit members. A key focus of the Working Papers is the promotion of the rights of refugees in South Africa and the global South.

The Refugee Rights Unit remains not only committed to directly assisting refugees and asylum seekers but

also in teaching and engaging in research which can be used to promote and further the law in this area and as an advocacy tool in the future. The Unit has compiled a Refugee Law textbook titled *Refugee Law in South Africa*. Members of staff also write refugee law related articles for the purpose of publishing in peer-reviewed journals.
